Since they had not opted for parallel operations of the captive

generating plants with the grid without availing open access, they are not

liable to pay Parallel Operation Charges ("POC"). According to Respondents

there was second tariff Order in August, 2017 wherein they modified earlier

Tariff Order and second Tariff Order is not challenged by the Appellant. In

terms of Madras High Court order referred above the POC was from May,

2014 to January, 2019 and Madras High Court has stayed all proceedings

consequent to order of stay granted referred to above. In that view of the

matter, we direct the Respondent Discom not to precipitate the matter in

terms of demand notice now under challenge till next date of hearing.

Objections by the Respondents shall be filed on or before 11.11.2019

with advance copy to the other side.
