The Ministry of Panchayati Raj, in close collaboration with the Ministry of Education (Department of School Education & Literacy) and the Ministry of Tribal Affairs, is launching an innovative initiative - the Model Youth Gram Sabha (MYGS) on 30th October, 2025 at the Dr. Ambedkar International Centre, New Delhi.

The initiative reflects the Government's firm commitment to engaging youth in the nationbuilding process by nurturing informed, responsible, and participative citizens. It seeks to familiarize students with the principles and processes of the Panchayati Raj system, helping them understand how local governance directly shapes community development and everyday life.

It aspires to build a generation that values inclusion, community participation, and ethical leadership - qualities at the heart of a confident and progressive India.
